Fund Overview, Objectives and Strategy

qmetrica uses proprietary machine learning algorithms to identify and capitalize on statistical patterns that are present in security prices. The portfolio, which focuses on large-capitalization U.S.- and Canadian-listed equities, consists of approx. 60 positions and is rebalanced on a weekly basis. The net exposure of the portfolio is also adjusted dynamically every week in order to maximize returns, yet maintain the level of risk exposure substantially below that of the market benchmarks. In addition, the Fund's downside risk is hedged through the periodic use of an overlay of certain securities based on the output of our model.

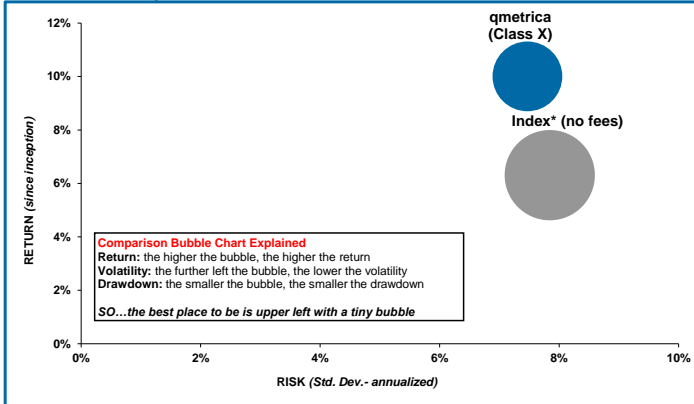

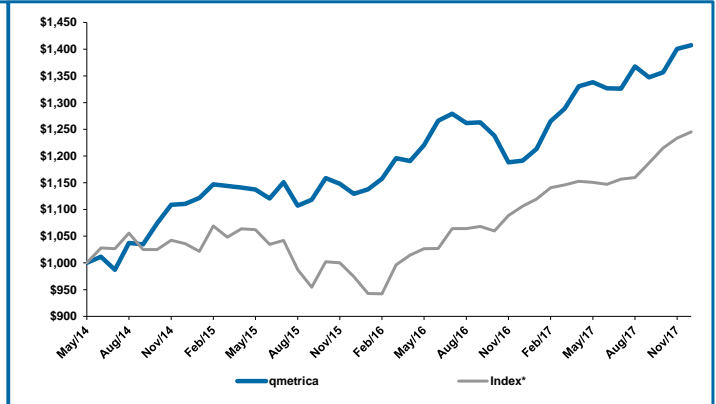

Risk-Return Comparison



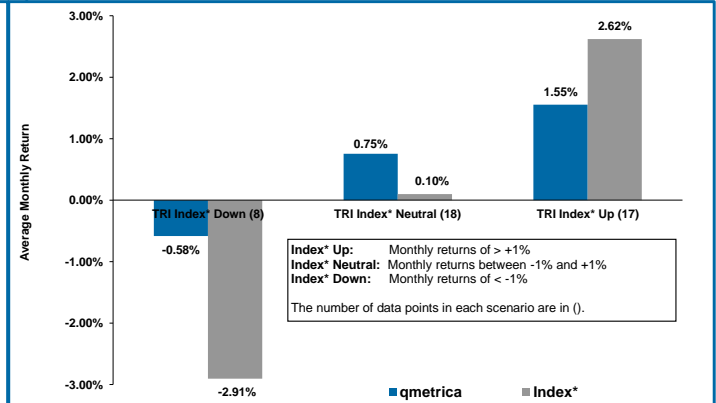
Growth of \$1,000
